Changes to Benefits Support

We have received new information from the folks in Benefits Administration that there will no longer be local support for retirees. Active employees are directed to go through the new Benefits Advocate Center (BAC) at the number in Texas.. The BAC cannot assist retirees. Benefit questions from retirees regarding medical issues should be directed only to Aetna. If something is escalated beyond Aetna's capabilities, the team in Houston would address, and have Aetna respond with the resolution.

If there is a retiree with a pension payroll question, address change, or to report a death, the retiree/beneficiary should continue to use the Sunoco Helpline (1-800-666-6323) to leave a voicemail and then await a reply. The payroll and life insurance support for retirees will soon be migrated to a voicemail system in Houston. The Sunoco Helpline will be updated with the Houston information once it becomes available, and will remain available for a transition period.

Changes in our membership profile

For the months of May, June, and July, only 18 people retired from the prior Sunoco organization and its successor groups. This of course impacts our future as our numbers decline over the years. We are of course, fortunate that so many of us still want to remain in fellowship and keep in touch.
