Information about Energy Transfer Partners GP, LP. Postretirement Medical and Death Benefit Program

Many of you have asked about the Sunoco trust that was set up by Sunoco to pay for retiree Medical and Death benefits. Energy Transfer is required to file information about this trust every year. This information is made available via www.efast.dol.gov. If you want to look up the filing select “Form 5500/5500-SF search“ in the top left hand corner of the site. Then on the next site page fill in the EIN number “593630327” and PN (plan number) “507”. Then click on the search button. When the search completes you will see a listing of reports. If you click on a EIN number it will download the report. The last report was filed for 2017 in Oct of 2018. It is 129 pages long. Most of it is the form ETP needed to file out. But at the end of the report is the Auditor summary which is more readable. We wanted to let you know how to find this information, but we are not qualified to interpret it for you or answer any of your questions. I’m hoping that the Auditors summary will help.
