Changes to Benefits Support

We have received new information from the folks in Benefits Administration that there will no longer be local support for retirees. All questions should be directed to the ETP voice response system, or be handled via email. Benefit questions from retirees regarding medical issues should be directed only to Aetna. If something is escalated beyond Aetna's capabilities, the team at ETP in Houston would address, and have Aetna respond with the resolution.

If there is a retiree with a pension payroll question, address change, or to report a death, the retiree/beneficiary should continue to use the Sunoco Helpline (1-800-666-6323) to leave a voicemail and then await a reply.
